The 2nd Executive Council Meeting of Arunachal Pradesh University, Pasighat was held on 22.11.2023 in the Mini Conference Hall of Secretariate of the Vice-chancellor of Arunachal Pradesh University, from 10 am onwards in blended mode, under the chairmanship of Prof. Tomo Riba, Vice-Chancellor. In the meeting the following members were present.

Shri Amjad Tak, IAS, EC Member and Commissioner, Department of Education Government of Arunachal Pradesh joined the meeting in virtual mode. The nominee of UGC Chairperson, Dr. Avneesh Mittal also tried to join the meeting in virtual mode. However, owing to poor internet connectivity on the part of university, he could not join the meeting and thereby was granted leave of absence.

The meeting started with a formal welcome address from the Chairman of the EC, Prof. Tomo Riba, VC, followed by appraisals of the agenda items of 2nd EC Meeting. He also reiterated that due to lack of regular non-teaching staff, the VC and Registrar are finding difficulties in office management. Also, he informed that, despite all the odds, university has successfully started academic programmes in five discipline/courses from academic session 2023-24. Further, he informed that the university has successfully completed the recruitment process for filling up of 9 (nine) out of 14 (fourteen) teaching positions. He further informed that end the semester examination of first semester students will be held in the month of December 2023. Further, he expressed his deep concern in delay in appointment of Controller of Examinations, though the university examination is nearing.

 ii. The EC approved the recommendation of the Selection Committee for appointment of Associate Professor in Tribal Studies.

iii. The EC perused in detail, the comment of the Selection Committee regarding lack in clarity about the age of retirement a professor of the candidate who was interviewed for the post of professor in the Department of Tribal Studies. Dr. S.N. Jha, the former OSD of this university has retired from his job on superannuation as an Associate Professor on 31 July 2023, at the age of 60 years. According to the UGC guideline, the retirement age of a university teacher is 65 years.

As per the Act of Arunachal Pradesh University, the retirement age of Vice-Chancellor and Pro-Vice-Chancellor is 65 years, Clause 10 (2)(b), at page-6 and Second Schedule 2 (1) at page-14. In this same schedule no 3(1) page 14 and schedule 5 (2), page-15, the retirement age of Dean and Finance officer is 60 years. Deans are appointed from/among the senior professors. Thus, it infers, the retirement age of a professor in Arunachal Pradesh University is 60 years.

Finally, after the long deliberation, EC agreed upon to keep the matter in abeyance and invoke the Arunachal Pradesh University Act 2012, No-5 at clause 12 (6) and forward the matter to the Honourable Chancellor for his final decision. The said clause advocates "If the
