In accordance with the provision laid down in the Arunachal Pradesh University Act no.5 of 2012 at clause no. 17 (1-6), the Vice-Chancellor is pleased to constitute the first Court of Arunachal Pradesh University, Pasighat with the following members for the three years, except the Ex-officio members, from November 2023 to May 2026. The Court shall hold, control and administer the property and fund of the University and shall conduct the administration of all finance affairs of the University in accordance with (Statute no. 7(1) of the second schedule of the Arunachal Pradesh University Act of 2012. The Court shall meet at least thrice every year to examine the account and to scrutinize proposal for expenditure.
