NOTICE

In continuation of the Admission Notification No.APU/89-APUCET/2024/4547/11 dated 24.06.2025 released by the Arunachal Pradesh University, Pasighat, inviting applications to various Post-Graduate Programs offered by the University, all the Prospective Applicants are hereby notified of the following instructions and necessary admission criteria related to the Arunachal Pradesh University Common Entrance Test (APUCET-2025-26).

- 1. The APUCET is a **Two-Stage Process** comprising of the First stage of a **Written Test** followed by a Second Stage of a **Personal Interview**.
- 2. All the Eligible Candidates are required to compulsorily appear for the written test.
- 3. Based on the result of the written test, a short listing of candidates for the Personal Interview shall be done.
- 4. The maximum number of candidates shortlisted for the Personal Interview shall be in the ratio of 3:1 of the total number of available seats in each department.
- 5. There will be another stage of Group Discussion for M.A in Social Work (MSW) candidates. Those selected for Personal Interview shall first take part in the Group Discussion Session.
- 6. The eligibility for admission shall be solely based on the merit in the APUCET.
- 7. The Reservation to the Admission shall be as per the prevailing 80:20 Reservation policy of the Government of Arunachal Pradesh
- 8. Special additional weightage, over and above the marks secured in the Written Entrance test, shall be given to Sportspersons (5% for International, 3% for National, and 2% for Regional), NSS Volunteers (3% for participation of 120 hours and above), and NCC Cadets (3% for attaining 'C' Certificate and 2% for attaining 'B' Certificate).
