ELIGIBILITY CRITERIA NOTICE

As per the **Lyngdoh Committee Report-2006 (Clause 6)** and Honourable Supreme Court of India Guidelines on student elections in Colleges/Universities, the students fulfilling the following criteria are eligible to contest the Arunachal Pradesh University Students' Union Election-2025:

1. He/she must be a bona fide regular student of the University during the current session.
2. He/she must not be above 25 years of age in case of PG students and 28 years of age in case of research scholars as on the day of the issue of the Nomination Paper, i.e., 24th October 2025.
3. He/she should have attended 75% of the attendance as on the day of the issue of the Nomination Paper, i.e., 24th October 2025.
4. He/she should not have any academic backlog (arrears) during the current session. Compartmental/readmitted students are not eligible to contest.
5. He/she has only one opportunity to contest for the post of class representative or any other office bearer during their academic tenure.
6. He/she should not have any past criminal record.
7. He/she can contest for one post at a time.

MODEL CODE OF CONDUCT

In view of the office notification issued by the competent authority of the Arunachal Pradesh University, Pasighat, for conducting the Arunachal Pradesh University Students' Union Election-2025, the **Model Code of Conduct** as per the **Lyngdoh Committee Report-2006 (Clause 6)** and Honourable Supreme Court of India Guidelines on student elections in Colleges/Universities come into force with immediate effect. The following **Codes of Conduct** shall be binding on all the contesting candidates as well as the voters up to the **Declaration of Result**.

1. No candidate shall indulge in, or shall abet any activity, which may aggravate existing differences or create mutual hatred or cause communal, linguistic, or religious tensions.
2. Candidates shall refrain from criticism of all aspects of the private lives of other candidates and their supporters. However, unverified allegations or distortions of facts shall be avoided.
3. There shall be no appeal to caste or communal feelings for securing votes.
4. Places of worship shall not be used for election propaganda.
5. All candidates and their supporters shall be prohibited from indulging in any kind of corrupt practices and offences such as bribing, intimidation and impersonation of voters, providing conveyance/transportation facility to the voters to and from the polling station.
6. No candidate would be allowed to carry out processions or public meetings outside the university campus.
7. No candidate shall, nor shall his/her supporters deface or cause destruction to any public property.
8. The use of loudspeakers, vehicles, and animals for the purpose of canvassing is strictly prohibited.
9. Any type of canvassing/campaigning before 24 hours, from the hour fixed for the commencement of polling, is strictly prohibited.
10. On the Day of Polling, there will be no canvassing in any form within a 100-metre radius of the Polling area.

In addition to the above code of conduct, Section 153-A and Chapter IXA of the Indian Penal Code, 1860 will apply to this election.

Any contravention of the above Codes would invite disciplinary actions. The candidates are liable to be stripped of the candidature, or his/her elected post, as the case may be, for such contravention.
