**NOTIFICATION**

Pursuant to the decision taken in the 2<sup>nd</sup> Academic Council Meeting held on 29 September 2025, under Resolution No.AC-02-12, and ratified in the 5<sup>th</sup> Executive Council dated 30 September 2025, Temporary Affiliation is hereby granted to Government Model Degree College Kanubari, Longding District for two years from the current Academic Session 2025-2026 to 2026-2027, subject to the fulfilment of the following observations:

| 1       | The college is being administered by the principal in-charge which needs appointment of a regular Principal.  | Observation endorsed by the Academic Council (AC) |
| 2       | There are only two regular Assistant Professors working in the college, supported by guest faculty members. There is an immediate need of appointment of at least two more Assistant Professors in each department for starting of new batch. | -do-  |
| 3       | There is no separate college library building. A regular Librarian needs to be appointed.   | -do-  |
| 4       | As a temporary measure, the college has engaged staff from District Administration. Hence, regular Non-Teaching staff for college needs to be appointed.  | -do-  |
| 5       | There are no hostel facilities in the college premises. Hence, College Bus is to be provided.   | -do-  |
| 6       | College needs to have its canteen for benefit of staff and students.  | -do-  |

As such, the college authority shall apply for Temporary Affiliation/Permanent Affiliation at least 2 (two) months prior to expiry of the two-year Temporary Affiliation.

The Permanent Affiliation shall be granted subject to compliance and adherence to the academic and administrative standards as prescribed by the University Grants Commission and Arunachal Pradesh University Ordinances which will be monitored and assessed from time to time by the APU Authority.
