Pursuant to the fulfillment of conditions recommended by the Inspection committee and the approval granted by the Hon'ble Vice-Chancellor, Temporary Affiliation is hereby granted to Namdapha Degree College, Miao, Changlang District for 1(One) year from the current Academic session 2026-2027, subject to the fulfillment of the following observations:

1	The affiliation shall be ratified in the 5 th Academic Council Meeting.	Non-ratification by the AC shall lead to cancellation of affiliation
2	The affiliation is granted for B. Ed. course only.	—
3	The first semester of academic session 2026-2027 is to be extended till January 2027	As the starting of the Academic session has been delayed for this college, therefore the end semester examination shall take place in the month of January 2027, one month later than the usual academic session of the University

As such, the college authority shall apply for renewal of Temporary Affiliation (two) months prior to expiry of the one-year Temporary Affiliation on annual basis.

Further, the college shall become eligible to apply for a permanent affiliation only after the successful completion of 3 (three) consecutive years under temporary affiliation.

The Permanent Affiliation shall be granted subject to compliance and adherence to the academic and administrative standards as prescribed by the University Grants Commission and Arunachal Pradesh University Ordinances which will be monitored and assessed from time to time by the APU authority.

The Affiliation ID for Namdapha Degree College is 'APUAID/2604'.
